## REACH - Declaration (valid only for absolute shaft encoders ROTARCOD)

Our company is a manufacturer of electronic products, in terms of REACH a so-called "downstream user". We exclusively manufacture non-chemical products and use market conform components for production.

In addition, under normal usage and reasonably foreseeable conditions, there shouldn't be a release of substances. Therefore, our company is generally not subject to the registration or the obligation to produce safety data sheets.

The list of SVHC is published and was updated last on June 27, 2018. It contains a total of 191 substances. According to our current state of knowledge, our products – including components and packing materials –do not contain substances that are part of the list of SVHC in amounts greater than 0.1 weight-%. Neither do we use substances listed in Annex XVII in restricted applications. But since last update of the SVHC list, we use the following exceptions:

- 1.) Lead, CAS-No. 7439-92-1, as alloying element in turned or milled metal parts
- 2.) Octamethylcyclotetrasiloxane (D4), CAS-No. 556-67-2, Deca-methyl-cyclopentasiloxane (D5), CAS-No. 541-02-6, Dodeca-methyl-cyclohexasiloxane (D6), CAS-No. 540-97-6, in VITECTOR DW Airwave Switch Products

Independently, we are intensively pursuing, in our own interest, and to ensure a high level of product safety for our customers, the implementation of REACH on part of our suppliers. We are in close communication with our suppliers of chemical substances and preparations (for example, raw materials and supplies for the manufacture (RHB), treatment and processing of the products or application in otherwise operational processes). And we will embed the pre-registration of the products respectively later registration of the relevant substances in REACH in our supplier qualification.
